## Truck and Trailer Damage Waiver Agreement

### Terms, Conditions, and Coverage Selection

This Agreement sets forth the damage coverage options available to renters of Joyride Rentals LLC’s snowmobiles and accessories. All coverage options described herein are subject to the express terms and conditions of the rental contract.

**COVERAGE DOES NOT INCLUDE: INJURY, PERSONAL PROPERTY, OR DAMAGE TO THE VEHICLE OR TRAILER RESULTING FROM NEGLIGENCE OR INTENTIONAL CONDUCT, INCLUDING USE FOR ILLEGAL PURPOSES OR OPERATION UNDER THE INFLUENCE OF DRUGS OR ALCOHOL. USE OF THE RENTAL IN RESTRICTED AREAS (SUCH AS WILDERNESS AREAS, CREEK CROSSINGS, RESERVOIRS, OR ANY BODIES OF WATER) IS STRICTLY PROHIBITED.**

The renter is liable for any damages not covered by the selected option. **This Agreement only covers accidental damage to snowmobiles and/or accessories.**

Not including damage resulting from parking brake being left on. Recovery charge not covered ( <b>\$400</b> minimum). Theft not covered. Authorization to charge credit card <b>\$3,000.</b>	Pays <b>\$3,000.00</b> per occurrence. Recovery charge not covered ( <b>\$400</b> minimum). Loss of use daily rental fee limited to 7 days minimum. Theft not covered.	<b>\$3,000.00</b>	

<b>Option C</b>	<b>Adams 3 &amp; 4 Place Trailer</b> \$25.00 per day. Damage to snowmobile – Renter pays \$1,500 per occurrence. Includes all accidental damage to trailer and accessories. Not including damage resulting from improper use, such as improperly connecting trailer to vehicle or leaving ramps down or out while towing. Recovery charge not covered (\$400 minimum). Theft not covered. Authorization to charge credit card \$1,500.	Pays \$1,500.00 per occurrence. Recovery charge not covered (\$400 minimum). Loss of use daily rental fee limited to 5 days minimum. Theft not covered.	<b>\$1,500.00</b>
